

## REFINERY29 | H&M COACHELLA FESTIVAL CONTEST OFFICIAL RULES THIS CONTEST IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK OR INSTAGRAM NO PURCHASE NECESSARY.\_ A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW

1. <u>Eligibility:</u> H&M Coachella Festival Contest (the "Contest") is open only to legal residents of the forty-eight (48) states of the Continental United States and the District of Columbia, who are <u>18</u> years of age or older at the time of entry. Employees of Refinery 29 Inc. ("Refinery29") and H&M Hennes & Mauritz (H&M) and their parent and affiliated companies, subsidiaries, promotion agencies, suppliers, and members of their immediate families, are not eligible. For purposes of this Contest, "immediate family" is defined as spouses, parents, children, siblings and their respective spouses, regardless of whether they reside in the same household.
