

**STYLE SCORES SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

Style Scores Sweepstakes (the "Sweepstakes") starts on 11/3/2014 (at 12:01am EST) and ends on 11/24/2014 (at 11:59pm EST) ("Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes is open solely to legal residents of the forty-eight (48) contiguous states of the United States, excluding Rhode Island, who are eighteen (18) years of age or older at the time of entry. **ALTERNATIVE METHOD OF ENTRY ("AMOE"):** Participants may also enter the Sweepstakes by mail as follows.
