

## REFINERY29 BEAUTY WITH MI NEW YEAR SWEEPSTAKES (the "Sweepstakes")

### Official Rules

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, HAWAII, AND RHODE ISLAND AND WHERE PROHIBITED BY LAW.**

This Sweepstakes may only be entered in or from the forty-eight (48) contiguous United States (excluding Rhode Island), and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry.
