

**REFINERY29 + DOWNTOWN ALLIANCE + BROOKFIELD PLACE SWEEPSTAKES (the  
“Sweepstakes”)**

**Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND

**This Sweepstakes may only be entered in or from the forty-eight (48) contiguous United States (excluding Rhode Island), and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States.
